The Puerto Rico Highway and Transportation Authority (the Authority) will receive sealed proposals for the service mentioned below:

Update and Migration from Oracle eBusiness Suite version 11 to the latest version 12

The current billing process will be improved by the creation of a new Federal Aid Billing Process (SOP) and upgrading the existing Oracle E-Business Suite that currently handles the Authority's Financial System, as well as incorporating it to the Program and Project Portfolio Management Software procured. This upgrade will handle the necessary financial controls and streamlining required to process applications for payments in less than 40 calendar days, maintaining superior budget and funding controls, among other effective monitoring tools.
