PUBLIC NOTICE

The U. S. Department of Transportation (DOT) requires that the Federal Highway Administration (FHWA) and the Federal Transit Administration (FTA) certify the Transportation Management Area's (TMA's) planning process. Urbanized areas with 200,000 habitants or more in population are referred as TMA in the federal legislation. In Puerto Rico, San Juan and Aguadilla are the Urbanized Areas, under this category.

This process will be conducted by the Federal Agencies between the Tuesday, 6th to the Friday, 9th of December 2016 in the Department of Transportation and Public Works (DTPW) and Puerto Rico Highway and Transportation Authority (PRHTA). The purpose of this review is to certify that the transportation planning process developed in Puerto Rico complies with the 23 U.S.C Section 134 requirements and other applicable requirements of Federal law.

Therefore, we invite the members of the Metropolitan Planning Organization, Urbanized Areas with 200,000 habitants or more in population and the general public to participate in this process. The meeting schedule is the following:
